

IRON HORSE LIMITED LIFETIME WARRANTY

Iron Horse Bicycle frames purchased from an authorized Iron Horse Bicycle dealer are warranted by Iron Horse to be free from defects in material and workmanship under normal use as long as the bicycle is owned by the original owner.

The terms of this frame warranty are as follows:

- 1. Steel or Cromoly - Lifetime**
- 2. Aluminum Hardtails and Cross Country Dual Suspension - 5 years from date of purchase**
- 3. Downhill Racing and Freeride Dual Suspension Frames - 1 year from date of purchase**

All original parts on bicycles purchased from an authorized Iron Horse Bicycle dealer, are warranted by Iron Horse to be free from defects in materials and workmanship under normal use for one (1) year from the date of purchase. This excludes normal wear items including but not limited to tires, tubes, shift and brake cables or housing, and chains. During each of the respective limited warranted periods, all original parts and bicycle frames subject to this limited warranty and determined by an authorized Iron Horse dealer to be defective in material or workmanship will be repaired or replaced by Iron Horse, through an authorized Iron Horse Bicyclist dealer, free of charge, except for shipping or other transportation charges and dealer labor charges which are not covered by this limited warranty. This limited warranty applies only to Iron Horse Bicycles, which were fully assembled by an authorized bicycle dealer at the time of purchase and were not altered in any way inconsistent with the bicycle's design. In order to obtain limited warranty service, the bicycle, together with the bill of sale/assembly, must be presented to an authorized bicycle dealer.

Notice: The user assumes the risk of any personal injuries, damage to, or failure of the bicycle and other losses if Iron Horse Bicycles are used in any competitive event (including bicycle racing or bicycle motocross, dirt biking, dirt jumping, freestyle riding, or similar activities or training for such activities), altered in any way inconsistent with the bicycle's originally designed purpose, used for stunt riding, to tow another person or vehicle, used with motors or any power driven apparatus. Any of the foregoing will invalidate this limited warranty and Iron Horse shall not be liable for any failure, loss, damage, or injury resulting from such uses or alterations. Iron Horse shall not be responsible for incidental or consequential damages. This limited warranty does not cover any personal injuries, damages to or failure of the bicycle or any other losses due to accident, misuse, alteration, neglect, abuse, normal wear and tear, improper assembly, improper fit, improper maintenance or use of unauthorized replacement parts or parts not designed for the bicycle. This limited warranty is the only warranty applicable to Iron Horse Bicycles and is expressly in lieu of any other warranty. Any implied warranty, including any warranty of merchantability of fitness for a particular purpose, is limited in duration to the duration of this express warranty. This limited warranty gives you specific legal rights and you may also have other rights, which may vary from state to state. This limited warranty applies only to the United States.
